

Waukesha County Huber Facility Electronic Monitoring (EM) Program Information February 18, 2010

1. Sheriff's Department EM Program Eligibility Requirements

- a. You must be at least 18 years old and sentenced. Bailees will not be considered for the program.
- b. You must have a total sentence time of at least 21 days.
- c. You must have a place of residence within certain geographical boundaries.
- d. You must have a standard analog phone in the home or be able to have a phone line installed which includes no custom calling features (call waiting, caller ID, call forwarding, etc.)
- e. Charges: You will be eligible for consideration if convicted of a non-violent misdemeanor charge. Non-violent felony convictions are considered on a case-by-case basis. Charge history is also taken into consideration.
- f. Certain Alcohol Related Offenses will be considered. These include OAWI, BAC, Refusal, Underage Drinking, Fleeing (alcohol related). The following items will also be taken into consideration when determining eligibility if convicted of an alcohol related offense.
 - i. 1st, 2nd and 3rd OAWIs will be considered. You may have no other cases pending.
 - ii. You will be required to have completed a court ordered alcohol assessment, if applicable.
 - iii. You will also be required to provide proof you have been involved in an AODA program. You must have completed a substantial portion of this treatment.
- g. Present and past institutional disciplinary history will be taken into account when determining eligibility.

2. **Court Authorized Electronic Monitoring (EM).** Individuals who receive court authorization to be placed on electronic monitoring will serve the first three days of their sentence at the Huber Facility prior to being placed on the program. Inmates must maintain a satisfactory disciplinary record prior to being placed on the program. Huber Facility staff has the right to deny placement or revoke individuals off the EM program for drug use or other serious violations.

3. Monitoring Systems.

- a. **Bracelet.** All inmates on home detention will be monitored with an EM ankle bracelet.
- b. **Alcohol Monitoring.** All inmates placed on home detention for an alcohol related offense, in addition to the bracelet, will also be monitored with an alcohol sensing device.

4. **EM Program Cost.** The cost of this monitoring program is \$21 per day and it must be paid regardless of employment status. One week's program cost (\$147.00) is due prior to placement. The daily cost is subject to change annually.
